This year the following charities have been chosen and each charity has been donated £201.00 from the £804.00 collected from this year's Aarti.

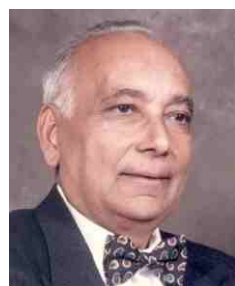

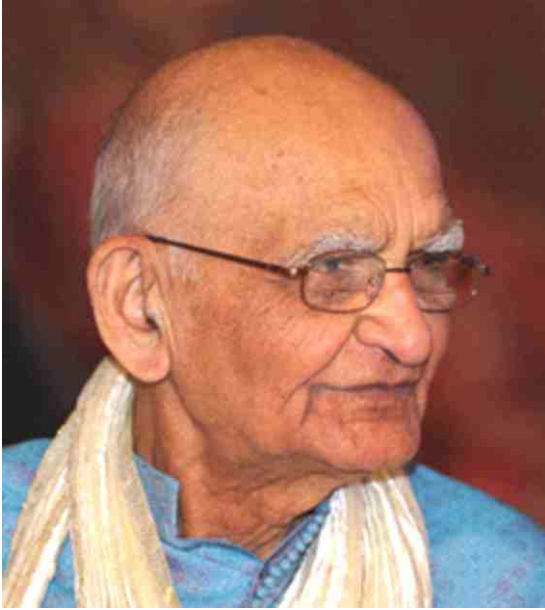

This is his legacy.

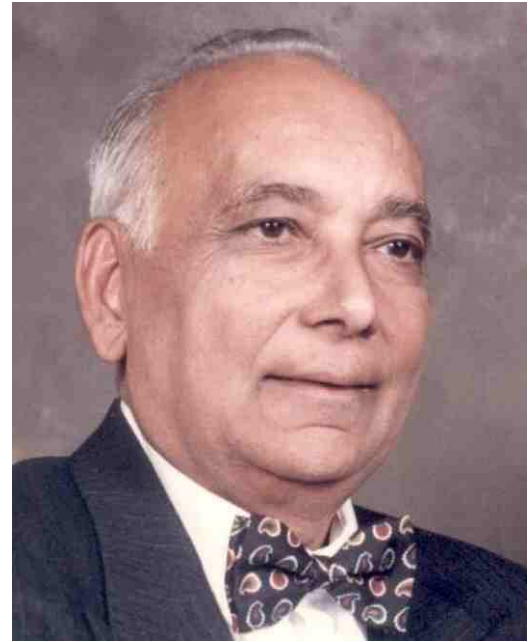
